- 3. All payments must be made via EFT. No cheques will be accepted. Cash payments or forex payments from international bank accounts may be subject to an additional administration fee in order to cover bank charges.
- 4. No booking will be confirmed unless the 500 booking fee is paid.
- 5. Should your wedding be cancelled for any reason whatsoever, your deposit is non-refundable. A refund will only be granted if the wedding is cancelled 6 months or more before the wedding date.
- 6. Should you cancel the booking less than 4 months before the date, the full amount of the quotation will immediately become due and payable.
